**NOTE:** Police Career Incentive Pay Program (PCIPP), an Amendment to section 18L of chapter 41 of the Massachusetts General Laws delegated to the Board of Higher Education (BHE) grants the authority to establish guidelines for program pursued for police career incentive pay increases. The BHE has subsequently adopted new standards, which **DO NOT** allow for Academic Credit to be granted for

- Life experience or military, police academy, or other training or;
- Academic credit for knowledge-based testing (CLEP, DANTES, etc.) to exceed 6 credit hours or;
- Tech-prep credit.

Students being re-admitted into the CRJ Program will enroll in the current program of study.
